In this regard, an IOM dated 24.04.2024 sent to RF & Law Wing, HO for advising on the above regarding filing or non filing of RSA before Hon'ble Punjab & Haryana High Court, Chandigarh. Vide its IOM dated 03.05.2024, Law Wing, HO has conveyed that on the above, suitable action will be taken by RO as per delegation of power and the same has been put up in CHRO on 10.05.2024. Accordingly, the decree has been accepted by the Competent Authority. As advised by Sh. Deepak Sharma, Advocate, Execution Application has been filed. Next date of hearing is 02.09.2025.

So, HUDCO is facing difficulties in locating the property. Also we can not participate in the bid in such bid process. Vide Order dated 05.10.2023 Court has disposed of the execution being dismissed for want of prosecution as mentioned above. Hence, at present no recovery case/ execution application is pending.
