11. Successful bidder will be required to deposit 20% of the successful bid amount within 7 days after setting off his Earnest Money Deposit failing which his Earnest Money will be forfeited.
12. The balance money i.e 80% of the successful bid amount is to be deposited by the Successful bidder within 45 days from the date of auction and if he fails to do so the amount deposited by him shall be forfeited.
